Here are a few income tax return tips you should know before lodging a tax return:

### Do you know what the tax free threshold is?

Did you know that Australian resident taxpayers have the first \$18,200 of their income tax-free? This is known as the tax-free threshold. This means that if you earn less than \$18,200 collectively, you won't have to pay tax at all.

This is important to know as it may mean that a full tax return is not required to be lodged. If a return is not required to be lodged, the ATO must still be notified that a return is not necessary. This will prevent the ATO from requesting a return for that year in the future.

If you have earned less than the \$18,200 threshold but your employer has deducted tax from your wages then you must lodge a tax return. In this case you would receive a refund of all your tax paid.

#### What do you so when you start a new job?

Starting a new job requires you to fill out a Tax File Number Declaration form. This means that if you have more than one job, and your overall income exceeds the \$18,200 amount, you can only claim the tax-free threshold on one payer, usually the higher paying one. Attempting to claim the tax free threshold for both jobs will result in a tax debt when lodging your tax return.

#### Do you know how to lodge your tax return?
